Harassment, Bullying & Discrimination Notice

The Minidoka County School District does not tolerate discrimination or bullying of any kind, especially such actions focused on students with disabilities. To ensure that violations of **Policy 372.00 Prohibition of Bullying, Harassment & Discrimination** are reported and dealt with in an appropriate manner, the district will annually share this notice with all students and parents.

Any student, and/or parents of a student, who believe the student is being harassed, hazed, intimidated, coerced, bullied, or discriminated against should immediately report the situation to school personnel, particularly if the actions are in relation to a disability. Such a report should also be made if any type of bullying or harassment is witnessed by a student or parent.

Examples of such behavior are making fun of a student's disability, making inappropriate remarks or texts about a student with a disability, or mimicking a student's disability. Such actions will result in discipline up to and including suspension or expulsion.

To report an incident of discrimination please contact the appropriate building administrator or the Superintendent as listed below. To file a written report please provide the information outlined in the **Policy 372.00F Harassment, Bullying & Discrimination Report Form**, (which can be obtained from any building office or on the district website) or in a letter containing the same information, to either the Superintendent or the appropriate building administrator.

Aviso del Acoso/*Bullying*, Intimidación y Discriminación Aviso

El Distrito Escolar del Condado de Minidoka no tolera la discriminación o el acoso de cualquier tipo, especialmente acciones centradas hacia los estudiantes con discapacidades. Para asegurarse de que violaciones de **Política 372.00 Prohibición de Intimidación, Acoso y Discriminación** son reportados y tratados de manera apropiada, el distrito anualmente compartirá este aviso con todos los estudiantes y padres de familia.

Cualquier estudiante, y/o los padres de un estudiante, que creen que el estudiante está siendo acosado, hazed (ritos de iniciación), *bullying*, coaccionado, intimidado, o discriminado debe reportar inmediatamente la situación al personal de la escuela, sobre todo si las acciones son en relación con una discapacidad. También se debe hacer tal informe si cualquier tipo de intimidación o acoso es atestiguado por un estudiante o padre de familia.

Ejemplos de tal comportamiento serian el hacerle burla a alguien con discapacidad, haciendo comentarios o textos inapropiados acerca de la discapacidad del estudiante o imitando la discapacidad de un estudiante. Estas acciones resultarán en disciplina hasta e incluyendo la suspensión o expulsión.

Para reportar un incidente de discriminación por favor póngase en contacto con el administrador del edificio apropiado o el Superintendente que se enumeran a continuación. Para presentar un informe por escrito por favor proporcione la información que se indica en la **Política 372.00F El Acoso, Intimidación y Discriminación Reportar**, (que se puede obtener en cualquier oficina del edificio o en el sitio web del distrito) o en una carta que contenga la misma información, ya sea a la Superintendente o el administrador del edificio apropiado.
